NOTES:

- 1) The fixed charges are per AWB.
- 2) The total fee to be collected is calculated as rounded up and in multiples of TL 5.
- 3) Charges for transit cargoes are notified to stations by Istanbul Cargo Management with an official letter.
- 4) If there are carriages (if any) required for returns due to customer's fault, they are charged separately. Additional necessities are included in the invoice separately.
- 5) CAO (Cargo Aircraft Only) carriages are not accepted for transfers to domestic bonded stations. However, they may be performed upon agreement of Turkish Airlines, provided that the consignor and/or consignee have obtained all the necessary permissions for transfer of such cargoes to domestic bonded stations and also accept all costs to be incurred on the transit route with the vehicle to be supplied.
- 6) In case of truck transports to bonded stations upon customer's demand, the customer is charged for the per vehicle carriage fees in addition to the fixed prices.
